PURPOSE STATEMENT – Community Correction Partnership

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)*, Presiding Judge of the Superior Court*, a County Supervisor or County Administrator, District Attorney*, Public Defender*, Sheriff*, the head of the Department of Social Services*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of the 2011 public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

Call to Order

The meeting was called to order at 3:00 p.m.

Chief Hansen welcomed members and requested introductions.

Approval of Agenda

Patrick Duterte made a motion to approve the agenda. The motion was seconded by Judge Beeman. No opposition. Motion carried.

Jennifer Washington presented statistical information pertaining to the Probation Department as of April 30, 2012.

Captain Gary Elliott provided information regarding Custody Division Realignment.

- Jail Population: 930
- Parolees 3056: 173 represents 18.6% of jail population
- 1170(h) (N3's): 133 in custody represents 14.3 % of jail population
- 3455 PC Violators: 18 in custody represents 1.9 % of jail population

Data Subcommittee Report - *(See Handout) Data Collection Committee Minutes*

Captain Gary Elliott reported that the subcommittee met on May 9, 2012 and continues to focus on the subcommittee's purpose and the information being tracked. The members of the subcommittee plan to attend the Criminal Justice Institute (CJI) Workshop on June 21, 2012. Captain Elliott also met with Fred Bridgewater, Regional Parole Administrator, regarding the data elements that CDCR collects which may be useful in analyzing the profile of the offenders who may be released from parole through CDCR.

Carol Cain presented an update of the committee's progress on the IT component. The Sharepoint server is being purchased along with the license which will allow County departments to share and store data in a secured location.

Substance Abuse/Mental Health Subcommittee Report - (See Handouts)

Report to CCP May 14, 2012 Substance Abuse/Mental Health Subcommittee Report for the Activities April/May 2012

Patrick Duterte reported statistical information on Mental Health/Substance Abuse referrals for April and May. The subcommittee and the City County Coordinating Council (4Cs) also received a presentation from Leon Evans, CEO& President for Health Care Services in Texas.

DRC Subcommittee Workgroup Report - Chief Deputy Donna Robinson reported that the workgroup has met twice. The workgroup is working with Probation's IT Staff to develop a report outlining the profile of the PRCS offenders under supervision. This quantitative report will be based on the information in the department's CASE Management system. Several members from the workgroup will also tour the Day Reporting Center in San Joaquin County.

Sanctions Grid Subcommittee Report – Jennifer Washington reported the subcommittee reconvened and will examine offender's behaviors which were not addressed on the Sanctions Grid that is currently included in the Public Safety Realignment Plan. A follow-up meeting is scheduled for May 30 to draft a proposal which will be presented to the CCP in June.

Budget Report and Request – (See Handout) Memo – Public Safety Realignment (AB109) Budget Report

Ron Grassi presented an updated budget report which included projections for the third quarter. The budget for FY 2011-2012 totaled \$5.9 million. The CCP was asked to render a vote on the allocations outlined in the report. A discussion occurred regarding the department allocations outlined in the report after the District Attorney challenged the proposed allocation to the Conflict/Public Defender Office.

Sheriff Stanton made a motion to fund the Conflict/Public Defender and District Attorney's Offices equally. Both departments will be able to request additional funding from the CCP at a later date. Patrick Duterte seconded the motion. Motion carried 5-1. Public Defender, Lesli Caldwell opposed, and Judge Beeman was absent from the vote. Motion carried.

Committee Comments – Patrick Duterte suggested the committee address issues as housing in addition to the criminogenic thinking.

The next scheduled meeting is June 13, 2012 at the Solano County CAC Building, 675 Texas Street, 6th Floor, Conference Room 6004 from 3:00 p.m. to 5:00 p.m.
