## PERMITS

### ENCROACHMENT PERMITS

**Standard Permit** (including single-family residential driveway/traffic signage) \$455(\*Note)

**Major Permit** (roadway trenching, traffic control, commercial driveway, and other complex projects) \$795(\*Note)

In addition, an annual encroachment permit fee of \$120 per 1/10 mile of roadway or \$ 0.23 per foot for encroachment less than 1/10 mile in length to be collected if the owner of the encroachment is other than an adjoining property owner, public agency, or public utility company. The Director of Resource Management may waive the annual fee when the cost of collecting the fee is greater than the actual fee.

### GRADING PERMITS

**Grading Permit Application and Determination** \$166

**Minor Grading Permit** (Includes \$166 Grading Plan Review Fee, plus Initial Deposit of \$954) \$1,120(\*Note)  
Note: A bond may be required

**Major Grading Permit** (includes \$166 Grading Plan Review Fee, plus initial Deposit of \$2585). The following \$2,751(\*Note) may be required: a soils engineering report, an engineering geology report and a bond. Should outside engineering services be utilized for plan checks of grading plans, additional monies may be charged in addition to the deposit and processing fee.

**OIL AND GAS WELL PERMITS** \$764

Collected by the Planning Division with the drilling permit. Installation of the well must include a \$50,000 bond per site with the application.

### TRANSPORTATION PERMITS

Per Trip ( for oversized loads and vehicles) \$16  
Annual Trip Permit (Restricted to legal loads) \$65

### ASSEMBLY PERMITS

Non profit organizations are exempt \$627

### NON-COMPLIANCE FEE (Hourly Rate)

The issuance of Notice of Violation for investigation of permit non-compliance. \$165

\*Note: The amount listed is the minimum deposit. An additional deposit may be taken for applications requiring extensive review. The applicant will be charged for the actual cost of performing the work.
