

COUNTY OF SOLANO NOTICE OF INTENT TO ADOPT AN INITIAL STUDY JAN 2 9 2025 AND MITIGATED NEGATIVE DECLARATION DIVISION OF THE PROPERTY OF THE PR

The Solano County Department of Resource Management has evaluated the allowed described below and has determined that a Mitigated Negative Declaration analyzing environmental impacts be prepared pursuant to the California Environmental Quality Act. PROJECT TITLE: Cache Slough Mitigation Bank Project (project)

PROJECT LOCATION: The project site is located at the southernmost reach of the Yolo Bypass at the confluence of Cache Slough, Sacramento River, and Steamboat Slough in Solano County, California.

PROJECT DESCRIPTION: The project would develop the Cache Slough Mitigation Bank (Bank), a private commercial mitigation bank, at the southernmost reach of the Yolo Bypass. The project would include a low water crossing under State Route 84 and would restore over 300 acres of tidal freshwater wetland and floodplain-associated vegetation communities within the interior of the project site that will expand available juvenile rearing habitat and increase food web support for at-risk Delta fish species.

The county, as the lead agency, has initiated the CEQA process to inform the county's discretionary decision on whether to approve the proposed project.

SIGNIFICANT PROJECT IMPACTS DISCUSSED IN DOCUMENT: The IS/MND did not identify any significant and unavoidable impacts; mitigation was incorporated, where necessary, to reduce all potentially significant impacts to a less than significant level.

PUBLIC REVIEW PERIOD: The IS/MND will be circulated for a 30-day public review period beginning on January 29, 2025 and concluding on February 27, 2025. In accordance with the State CEQA Guidelines, any comments concerning the findings of the IS/MND must be submitted in writing and received by the county **no later than 5:00 p.m. (Pacific Standard Time) on February 27, 2025**, in order to be considered.
