# **DEPARTMENTAL RECOMMENDATION:**

Consider adoption of a resolution modifying the Position Allocation Listing to effectuate position additions and reductions recommended on December 7, 2010 and December 14, 2010 for the Agriculture Department, Assessor-Recorder, Health and Social Services, Library, and the Treasurer Tax Collector County Clerk; and authorize the Human Resources Director to take steps necessary to effectuate a layoff.

## **SUMMARY AND DISCUSSION:**

It is recommended that the Board of Supervisors consider adopting a resolution amending the Position Allocation List to delete 8.5 filled and 7.4 vacant and add 4.0 new FTEs to achieve workforce reductions necessary to mitigate the General Fund structural deficit.

On December 7, 2010 the Board received reports from the County Administrator, the Assessor-Recorder and the Library detailing recommendations to delete and/or add new positions necessary to effectuate administrative reorganizations and position reductions required to mitigate the General Fund structural deficit. These reports indicated that the Human Resources Director would come back to the Board of Supervisors with a resolution which would effectuate the recommended changes to the Position Allocation List.

In addition, the Department of Health and Social Services is recommending on December 14, 2010 to delete 7.4 vacant positions, 1.0 filled position and add 3.0 new FTEs to be determined at a later date by the Director of Human Resources. Human Resources has conferred with the Director of Health and Social Services and the County Administrator's Office and has included these positions to the resolution for Board adoption.
