Introduction

Please be advised that the County of Solano Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for the Potrero Hills Landfill. The LEA is certified by the California Department of Resources, Recovery and Recycling to enforce state laws and regulations at solid waste facilities within the County of Solano.

Description of Project

Potrero Hills Landfill is an approximately 320 acre existing landfill site located at 3675 Potrero Hills Lane in Suisun, Ca. On March 10, 2011, the LEA received from Potrero Hills Landfill Inc. an application package to amend the RFI. This amendment proposes a revised final grading plan within the existing approved landfill footprint. The revised final grading plan does not change the existing acreage, permitted limits of waste (footprint), maximum height or disposed waste capacity of the landfill. No other changes to the solid waste facility permit are under consideration at this time.

LEA's Determination

Pursuant to Title 27, California Code of Regulations, section 21665(c), the LEA reviewed the application and has determined that the proposed change is consistent with the California Department of Resources, Recovery and Recycling State Minimum Standards, is consistent with all applicable certified and/or adopted CEQA documents, and does not conflict with the terms and conditions in the current Solid Waste Facilities Permit. The LEA approved the amendment on April 8, 2011.
