The meeting was called to order at 3:00 p.m.

➤ **Call to Order**

Group was welcomed by the Chair and introductions were made.

➤ **Public Comment**

An opportunity was provided for members of the public to address the Committee on matters listed on the Agenda—there were no comments.

➤ **Motions**

District Attorney Don du Bain made a motion to add to the agenda: reopen discussion of the plan in order to discuss an alternative proposal that he prepared. Second by Judge Daniels. Motion carried, 4-3, H&SS Director Patrick Duterte, Public Defender Lesli Caldwell and Chief PO Isabelle Voit opposed.

DA du Bain provided copies of his proposal to the group. A recess was taken to give time for review of the document. Motion by DA du Bain to consider his proposal for revision to the plan. Motion failed, 4-3, DA du Bain, Judge Daniels and Vacaville Police Chief Word in favor.

PD Caldwell made a motion to approve the version of the plan that was sent out on October 13. Second by Sheriff Gary Stanton. Motion carried, 4-3, Chief Word, Judge Daniels and DA du Bain opposed.

➤ **Public Safety Local Plan Development**

The committee discussed the funding request packet compiled by Robert Lawton, County Administrator's Office. Modifications were made to some of the requested amounts based on a later start since the realignment item will not get to the Board of Supervisors until November and many requests were based on a need for nine months of funding. Revised requested amounts are:

Total requested amount           \$3,612,140 leaving a balance of \$195,522

Motion by H&SS Director Duterte to approve the funding requests as presented and modified for recommendation to the Board of Supervisors. Second by PD Caldwell. Motion carried, 6-1, DA du Bain opposed.
