The Environmental Health Services Division has received feedback from individual operators asking if assistance is available. Staff are also spending time with individual businesses assisting them with entries into CERS, so there is a need.</li> <li>No information.</li> <li>Currently, there are over 1800 facilities that need to enter into CERS. It is anticipated that mainly small businesses and firms will require more assistance. There are approximately 900 of these types of small businesses, but not all are expected to seek assistance. It is anticipated that this project will provide assistance to at least 150 to 450 businesses. Obviously, the intent will be to assist as many businesses as needed within the bounds of the contract dollar amount.</li> </ol>
