## INFORMATION RELEASE ARRESTS MADE DURING COMPLIANCE CHECKS

01/30/14

On Tuesday January 28<sup>th</sup> Deputies from the Solano County Sheriff's Enforcement Team (SET), teamed up with officers from Solano County Probation, Fairfield Police Department, and the Dixon Police Department. The multiple agencies were broken into two teams and worked together to conducted compliance checks on subjects who are currently on Post Release Community Supervision (PRCS) in Solano County.

The Solano County S.E.T. team is composed of deputies from the Sheriff's Office, the U.S. Marshalls office, and an officer from the Fairfield Police Department. The team's primary function is to be the enforcement arm of Solano County Probation, who oversees PRCS participants, and to insure that persons currently released under PRCS are adhering to the terms of their release.

The operation was conducted over several hours and a total of 17 residences were visited by the two teams. Each residence was searched and if the target subject, who is currently on PRCS, was found to be in violation they were arrested and booked into the Solano County Jail.

The multi-jurisdiction teams combined to arrest 6 people. Arrested for violating the terms of their PRCS release were: 50 year old Fairfield resident HUGH LOPEZ, 32 year old Suisun resident VICTOR McCall, 45 year old Fairfield resident MICHAEL CONGDON, 38 year old Fairfield resident KEIJONA JACKSON, and 41 year old Fairfield resident TREVOR SHOPE.

Both Hugh Lopez and Michael Congdon were arrested on PRCS violations as well as additional charges of possessing methamphetamine smoking pipes. Victor McCall was arrested on a PRCS violation and booked on additional charges of possessing an illegally altered firearm, possession of a firearm by a convicted felon, and for committing a felony while out on bail. McCall was arrested after an altered 22 caliber rifle was seized from in his bedroom at his residence.

42 year old Fairfield resident SHAWN DERR was not on PRCS but was arrested for possession of a methamphetamine smoking pipe. Derr was contacted at the residence of a subject who is currently on PRCS.

The S.E.T. team and a team of Solano County Probation Officers conduct these types of sweep regularly to insure that subjects released on PRCS are following the terms of their release. The SET Team and Probation Officers also monitor PRCS subjects daily to insure they are within the guidelines of their release.
