"Read This Notice Carefully"

***** NOTICE TO REPORT IMMEDIATELY *****

You have been directed to attend a Driving Under the Influence (DUI) program. You must contact one of the programs listed below within 24 hours and provide proof of program registration to Solano County Court authorities within 30 days as directed in the court referral form.

The Superior Court of California, Solano County, provides referrals to programs for first and multiple offenders of DUI laws. These programs are approved and licensed by the State of California Alcohol and Drug Program and the Solano County Substance Abuse Program Administrator.

All licensed programs provide the following services: Intake/orientation; educational sessions; group and individual counseling sessions; face-to-face interviews. Depending on your DUI offense, the length of a program varies from a few weeks up to 18 months in duration. The program you choose will discuss program length, costs, and individual payment plans with you before registration. Bilingual services are offered. Be sure to bring all paperwork with you. Again, you are required to:

- Contact a program listed below within 24 hours of receipt of this notice
- Provide the Court with proof of registration as directed in court referral documents
