Introduction

Please be advised that the County of Solano Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for the Potrero Hills Landfill. The LEA is certified by the California Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste facilities within the County of Solano.

Description of Changes

The RFI amendment addresses the following changes:

- Update Section 7.3.7.3, Recycling Area No. 3 Wood Waste, Green Waste, Concrete and Asphalt Processing (page 65 substitute). This page describes the activities occurring in this area adjacent to the composting facility.
- Update Figure 3 (Site Plan) to reflect the installation of an additional landfill gas probe LFG-2R along the landfill's western permitted boundary commonly known as Phase I.
- Update Figure 6 (Final Grading Plan) to reflect the installation of an additional landfill gas probe LFG-2R along the landfill's western permitted boundary commonly known as Phase I.

- Update Figure 14 (Ancillary Facilities) to detail the Greenwaste/Woodwaste processing area and to reflect the change in the boundary of the Composting Operation within the portion of the landfill's permitted boundary commonly known as Phase I. The update also reflects the installation of an additional landfill gas probe LFG-2R along the landfill's western permitted boundary commonly known as Phase I.
- Update Figure 16 (Site Plan and Limits of Composting) to detail the Greenwaste/Woodwaste processing area and to reflect the change in the boundary of the Composting Operation within the portion of the landfill's permitted boundary commonly known as Phase I. The update also reflects the installation of an additional landfill gas probe LFG-2R along the landfill's western permitted boundary commonly known as Phase I.
- Amendment to Perimeter Gas Probe Monitoring plan, Appendix Q (Amendment No. 1, March 2014) to update the modifications made to the perimeter gas probe monitoring system since the September 2007 work plan.

LEA's Determination

Pursuant to Title 27, California Code of Regulations, section 21665(c), the LEA reviewed the application and determined that the proposed changes are consistent with State Minimum Standards, are consistent with all adopted CEQA documents, and does not conflict with the existing Solid Waste Facilities Permit. The LEA approved the amendment on April 24, 2014.
