#### A. <u>Solano Prevention Recovery Alliance (SPRA) – Kester McDonald:</u>

#### B. <u>Re-Entry/Community Corrections Partnership (CCP) – Andy Williamson:</u>

- CCP meetings are now quarterly, next meeting in Sept.
- Currently gathering AB109 data since it started in Oct. 2011 for a data presentation in Sept.
- Last Substance Abuse staff that will get hired on for the CPC Program is now in background process
- Probation Dept. is planning on using AB109 funds for other probationers; they also have AB672 funds for substance abuse treatment programs within their dept.; Probation has contracted with Walden House in San Francisco for inpatient treatment

#### C. <u>Substance Abuse Administrator's Report – Andrew Williamson:</u>

- New Licensed Mental Health Clinician staff in Vallejo: Paula Jean Adams
- Noelle Souza-Pense is still helping us in Vallejo because SBIRT has not started
- An 1115B Waiver has been submitted to CMS in Washington DC for a request to change drug services in Medi-Cal (including requirement for continuum of care)

- We have contracted with HealthRight 360 (formerly Walden House) in San Francisco for inpatient treatment which includes a dual diagnosis program
- Andy will be going to Santa Clara County next week with Carlissa James (BHAT Supervisor) to find out about their advanced system of care to get ideas on how to speed up our intakes in Solano County
- Second Chance Grant WRAP Graduation was on Aug. 7<sup>th</sup>; there were 9 graduates and support from Supervisors John Vasquez and Erin Hannigan

#### A. Community Listening Forum, Christie DeClue

"Recovery Works... Fund What Works!" will be the name of the Community Listening Forum. This is an opportunity to invite decision makers from the State and Local levels to listen to people in recovery speak about what works, and for the community to ask the decision makers to fund what works. The focus will be the positive in recovery and not what we lack in Solano County. Our hope is for the decision makers to see the positive and what has worked in recovery, and fund what works. This event will be on October 8<sup>th</sup> from 5:30 PM – 8:30 PM at 675 Texas St. Fairfield, Multi-Purpose Room.

Planning to have several dignitaries invited; testimonies will be 3-5 min in length; there will be two sessions and timely breaks; there will be a moderator; newspapers will be written to; message training will be provided to the speakers; Voices of Recovery format is being followed for this listening forum

#### **TOPIC: NEW BUSINESS**

#### A. <u>Presentation: Superior Court of California, County of Solano, Adult Drug Court, Judge Kam,</u> <u>Karen Sheey, and Caryn Brock</u>

Judge Kam: The Vallejo Drug Court began in 2013 and Fairfield Drug Court began in 1997. Drug Court is very different from traditional court. The idea behind it is a complete team approach: judge, probation officer, drug court case manager, offense attorney, and a district attorney. The team meets every other week to talk about cases. Drug Court does not focus on punishment but what's best for the client. If the client gets a violation, they get sanctions to help them get back on track. The first sanction is to sit in a jury box and write an essay; second violation is to do some community service; third, fourth, and fifth sanctions are jail time of no more than 10 days. They could be in jail for more than 10 days only if they are waiting to get into a program, not for a sanction. Last year, the Drug Court policy was revamped and the eligibility requirements were changed from persons charged with drug type crimes to low-level theft

crimes with drugs involved. People with prior or are currently charged with serious felonies such as violence, fire arms, etc., are still excluded. The program is a minimum of 18 months supervision. It has three phases: 1) 13 week recovery; 2) 13 week relapse and prevention; 3) 13 week after-care and support. The clients are required to meet with their counselor regularly, go to 12 step meetings, and their program. If the client successfully completes the program, their charge gets dismissed.

Caryn Brock: Caryn was a consumer in Solano County in 1993. She received services from Youth and Family Services and had a case manager that helped her tremendously. She applied for a Case Manager position for Drug Court and started working in February 2014, and was trained by Karen Sheehy. She works under the SAMHSA grant which has twice the amount of money for treatment programs than Solano County.

Karen Sheehy: Karen used to be a Criminal Defense Lawyer in Solano County. She realized she cared more about her clients' underlying issues than their legal predicaments. Karen has a father who is a heroin addict. He started struggling after a 16 year recovery. She has been to Al-Anon since 2004 and to other recovery related programs. When she found out about a job opening for a Case Manager in Drug Court, she applied, took the job, and closed down her own practice. Her biggest challenge is not having a place to send her homeless, pregnant clients due to lack of funding.
