A. Community Listening Forum, Christie DeClue

"Recovery Works... Fund What Works!" is the name of the Community Listening Forum. This is not a fundraising event; it is an educational event.

Community Listening Forum addressing "Recovery WORKS – Fund What WORKS." There is an elite 10-member panel of State, County, and Local decision makers in the following fields: Government, Health Care, Justice System, Legislation, and Business. Participation from our community's decision maker is vital and may be instrumental in changing Solano County in a profound and lasting way.

The Solano County Alcohol and Drug Advisory Board (ADAB) has partnered with Solano Recovery Project (SRP). We have planned and organized this Community Listening Forum. The panel will hear brief testimony from people associated with long-term recovery personally and/or professionally. These individuals are from diverse backgrounds and represent a cross section of Solano County and the state of California. Succinct personal stories will emphasize successes and highlight what needs to be developed in the area of recovery support services to ensure long-term recovery.

Each panel member has the responsibility to listen to speakers, to take notes, and to possibly make a brief statement to the audience at the close of the forum. Panel members are not expected to make any decisions, promises, or commitments—only to listen and to be inspired. The hope is by hearing positive testimony, decision makers will begin to place best practice ideas into action at every opportunity. Total time required from each panel member is estimated at three (3) hours on **Wednesday**, **October 8**, **2014**. The forum will be held from **5:30 PM** – **8:30 PM** at the **Solano County Government Center located at 675 Texas Street, Room 1600 in Fairfield, California.**

We believe that when the gaps between treatment and recovery are bridged, life-long recovery is not only possible—it becomes the expectation for anyone seeking freedom from substance use. Be an essential part of creating a world where everyone benefits from life-long recovery!

At the event, each invited speaker has 3-5 minutes to speak; there will be two sessions of six speakers each. Timely break has been scheduled between the two sessions. We have an experience and highly motivated moderator. Mandatory message training will be provided to the speakers on Sept 21st from 4-6pm at 711 Empire St FF to ensure that guidelines from Voices and Faces of Recovery are followed, and the focus of the Community Listening Forum is met throughout the event.

Our next planning meeting is directly after ADAB's meeting tonight.

We have several confirmed speakers. We have confirmed panel members. Response has been very receptive and positive.
