- Black Brown Summit on Nov. 12<sup>th</sup>-14<sup>th</sup> (Re-Entry Summit sponsored by Mt. Calvary Church)
- Youth & Family Services Treatment Programs closed on Oct. 31<sup>st</sup>; clients in their outpatient programs were transferred over to other County providers. Healthy Partnerships is currently looking into opening up a childcare at their sites so they are able to take in clients with kids. The YFS WRAP Program (Women's Re-Entry Achievement Program) was taken over by the County.
- Prop 47 was recently passed on Nov. 5<sup>th</sup>
- Substance Abuse is currently instituting quality assurance; there are staff going to providers' sites and going through a checklist to help providers meet Medi-Cal standards

#### A. Presentation: HealthRight 360, Cassandra Eslami, Managing Director of Mental Health Services

HR360 currently has two programs in Solano County: (1) Case Mgmt, Therapy, and Substance Use Disorder Services at the Adult Probation Dept. and (2) the New Directions and Challenges Program at the Juvenile Detention Facility. In addition to these two programs, they also have inpatient and outpatient programs in San Francisco, Los Angeles, and various prisons throughout the State of CA; Haight Ashbury Free Clinics (two free primary medical clinics); merged with Asian-American Recovery Services who offer services in San Mateo, Santa Clara, and San Francisco Counties; merged with North County Serenity House (residential & perinatal programs) in North County and San Diego; merged with Lyon Martin Primary Medical Services who provide services for transgenders in San Francisco, merged with Women's Recovery Association (inpatient & outpatient programs for women and women with children) in San Mateo; and merged with Glide Medical Services. HR360 provides fully integrated care for clients that include gender specific residential treatment, outpatient treatment, primary medical care, mental health treatment, re-entry services, family advocacy, and reunification services. They also provide substance use disorder and mental health services for offenders throughout the State of CA.

HR360 provides group and individual services at the Vallejo and Fairfield Adult Probation. They have two certified drug and alcohol counselors, one psychologist, and are currently hiring a treatment coordinator. Their services and treatment are geared toward an individualized, strength based approach to enhance motivation and lasting recovery. Their groups consist of motivational interviewing, motivational enhancement therapy, DBT, a new direction drug & alcohol education, a new direction relapse prevention, coping with stress triggers, and criminal thinking.
