## **TOPIC: COMMUNITY LISTENING FORUM: "RECOVERY WORKS – FUND WHAT WORKS"**

To keep the focus on RECOVERY, following September's National Recovery Month, ADAB, with the help of Solano Recovery Project, has put together this community listening forum to raise one's awareness about what works in the field of substance use treatment and recovery. The speakers have shared their testimonies from being substance users and some being incarcerated, to being in recovery and helping the community. The following services are what the speakers have indicated have worked for them in the past and what are needed now for the people seeking recovery:

- Treatment Programs on demand (no waiting lists)
- Residential Treatment Programs for women with children
- Jail services for women (empowerment groups, nurturing parenting program, peer mentor program, pre-release planning)
- Employment Guidelines/Job Training
- Housing, case management, warm hand-off from jail facility to housing facility for the mentally ill
- Long-Term Recovery Support Services
- Income
- Housing
- Detox
- Transitional Living/Safe & Sober Housing
- Wraparound Services
- Extended Care

Patrick Duterte, Health & Social Services Director, was very proud to share that CalFresh (CalWORKs and Foodstamps) is now available to people with drug felonies. Because this County, through the Board of Supervisors, made it a priority to take the legislation to the CA State of Association of Counties, it has been overturned.

County Supervisor Erin Hannigan says wrap-around services should be looked at for those people who are truly ready for a change. We should be looking at long-term recovery, transitional housing, and income for people before they even get to incarceration. She hopes that her colleagues and experts on staff can come up with some ideas on what the process would look like and how we can provide these services.

Ed Forrest, Chair of the Economic Development Committee of Vacaville, CA and also on the Board of Vacaville Community Housing, has learned the need of transitional housing and will find out more of what it entails and what can be done.

Youssef Elmanawy, Program Director of Phoenix House, says everyone is here for one reason and that is to continue the recovery path for everybody. In his opinion, there are a lot of resources and knowledge that we should put together to be able to move forward instead of reinventing the wheel. An issue he is currently facing with is the inmates receiving services in the prison, but once they are released, there are no continual of services.

Don Braeger, Division Chief of Prevention, Treatment, Recovery Services Division of the State of California, Dept. of Health Care Services, thinks that we do need to reinvent the wheel in some areas because it's the same wheel that's not moving us forward. The State is doing a lot of efforts in SBIRT (Screening Brief Intervention Referral to Treatment) for Adults and Youths. The State is also pursuing an 1115 demonstration waiver which they are trying to create and raise a more organized Drug Medi-Cal system. Some of the things the State is adding on to the waiver are recovery residence model and recovery services. For more information on the 1115 waiver, please go to the State's website.

Shawna Albright, Probation Services Manager of Special Projects, shared that Probation is working directly with Substance Abuse Services. There are Health & Social Services staff that are stationed at Probation. They also have a contract with HealthRight 360 for inpatient treatment program and they make sure their clients have the tools they'll need to continue.

The community clearly thinks the County should fund private groups as supposed to creating another agency within the government. The public-private partnership is the only way for sustainable results.

Tracey Lee has closed with some remarks:

Long-term recovery is real and is possible. We envision a day when policy makers, decision makers, and the public treat people with a substance use disorder like any other serious health condition. We trust that everybody will remember the stories and testimonies and that everybody will go out into the world and find ways to infuse what you have learned into our society. ADAB would like to thank all of the Panel Members, Speakers, and the Public for coming to this Community Listening Forum. We are so grateful that everyone took this time to be here with us. Together, we are going to change the world because we are worth it!
