The Solano County Board of Supervisors met in regular session on this day at 8:35 a.m.

The meeting was called to order by Chairman Thomson. Present were Supervisors Kondylis,

Silva, and Chairman Thomson. Supervisors Carroll and Kromm were excused.

Session at 8:59 a.m.

The Solano County Board of Supervisors reconvened on this day at 9:02 a.m. with the

Pledge of Allegiance and a moment of silence.

## **PRESENTATIONS**

RESOLUTION NO. 2001-11 HONORING DEPUTY SHERIFF PAUL WARHOVER UPON HIS RETIREMENT FROM THE SOLANO COUNTY SHERIFF'S OFFICE, ADOPTED

On motion of Supervisor Silva and seconded by Supervisor Kondylis, the Board acted to

adopt Resolution No. 2001-11 Honoring Deputy Sheriff Paul Warhover Upon His Retirement from

the Solano County Sheriff's Office. So ordered by a vote of 3-0; Supervisors Carroll and Kromm

excused. (see Resolution Book)

On behalf of the Board, Chairman Thomson presented Deputy Warhover with Resolution

No. 2001-11, recognizing him for over twenty-nine years of service to Solano County.

#### ITEMS FROM THE FLOOR

## APPEARANCE BY IAN ANDERSON RE ZONING ISSUES IN THE MONTEZUMA HILLS

Ian Anderson voiced his concerns regarding water related industrial zoning in the

Montezuma Hills area as it relates to food production. Mr. Anderson noted due to the zoning it is

not feasible to purchase some of this property for agricultural use, and feels this area should be

rezoned to agricultural uses. Mr. Anderson questioned if the Board would be look at this water

related industrial zoning, and with how the tipping fees that will be collected for the Montezuma

Wetlands project would be used.

### APPEARANCE BY BARBARA SHULTS RE ANIMAL CARE COMMISSION

Barbara Shults, Travis AFB, feels there is a lack of unity that is needed to overcome the many

obstacles that have plagued the animal shelter. Ms. Shults voiced concern with not having her

volunteer application processed, with negative newspaper articles, with the limits of the building the

animal shelter is in, and the many frustrations in trying to better the animal shelter.

#### DECLARATION, APPROVED

RESOLUTION NO. 2001-16 (RE EXPANSION OF H&SS HEADQUARTERS

BUILDING), ADOPTED.

Assistant County Administrator Darby Hayes gave a brief history of the Health and Social

Services Headquarters Building project, and reasoning for the request to add additional footage to

the building.

Director of General Services Jim Werdell noted the project is on schedule and on budget, the

environmental issues have been resolved, ground breaking should be in May, the cost of the

additional space will reduce the contingency to about \$400,000 to \$600,000, and that the bid for

construction did come in under budget.

County Architect Kanon Artiche reviewed the information contained in the Agenda

Submittal from his department dated January 23, 2001, incorporated herein by reference, noting the

progress of the design process, the site circulation, the child care center, parking capacity, an on sight

bus stop, the area planned for a children's' memorial. Mr. Artiche gave a brief description of the

facility, and showed some artist renderings of elevations of the building.

Responding to questions posed by Supervisor Kondylis regarding the use of solar power, and

the need to shade the parking lot, Mr. Artiche noted there is no solar capability at this time, but noted

sustainable concepts would be used within the project budget.

Chairman Thomson opened the public hearing. As there was no one who wished to speak on

this matter, the public hearing was closed.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

approve the addendum to the adopted mitigated negative declaration, and to adopt Resolution No.

2001-16 (Re Expansion Of H&SS Headquarters Building). So ordered by a vote of 3-0; Supervisors

Carroll and Kromm excused.

(Item 20) PRESENTATION FROM DON HARPER, DIRECTOR OF THE VIETNAM

VETERANS OF CALIFORNIA, INC., RE SACRAMENTO VETERANS RESOURCE CENTER

Don Harper, Director of the Vietnam Veterans of California, Inc., outlined the Vietnam

Veterans of California program, goals of the resource center for the reintegration of veterans, and

stressed the importance of partnerships with other groups and organizations in the community. Mr.

Harper further noted the importance of ensuring the veterans have program services, statistics on

homeless veterans. In beginning a program it is important to identify the population, and the gap in

services to address the special needs for the homeless veterans and homeless people in general.

Approximately one-third of the homeless are veterans, many veterans do no know where to get

assistance, many areas do not offer special programs for veterans, and there is a great need for

outreach programs. Mr. Harper noted the support of the Veterans Administration as a partner,

strategy tips for a successful program, and the need for a leadership group. Mr. Harper discussed

building of the facility for the resource center, funding sources, services available at the resource

center, the use of a case management system model with extensive up-front assessment, and again

emphasized partnerships.

Responding to questions posed by Supervisor Kondylis relative to women veterans, what

percentage of the veterans are homeless due to substance abuse, annual budget, Mr. Harper noted

2-3% of the homeless veteran population are women, and further noted services offered to these

women. Approximately 55% to 65% of the veterans are homeless due to substance abuse, another

major issue for these veterans are legal problems. The Sacramento Veterans Resource Center's

major goal is for employment and self-sufficiency. The operational budget for the center is

approximately \$12,000 to \$17,000 per month. Most of the money is from the VA per-diem process,

some from HUD, and donations from the community. There was a brief discussion regarding

expansion of the center with the assistance of community partners.

Responding to questions posed by Chairman Thomson regarding local participation in the

program, and with the effects of the homeless on businesses, Mr. Harper noted 85% of the

participants are from the Sacramento area, and that most veterans will stay in their local area to get

services. There was a brief discussion on the local business partners in addressing the homeless

issue in Sacramento.

Carl Young, Disabled American Veterans – Vacaville, provided the Board with an article

"Heroes Among the Homeless", incorporated herein by reference, discussing the general needs of

veterans. Mr. Young noted there is a need to address the underlying issues of the homeless, for

outreach services, and noted statistics on homeless veterans. Mr. Young discussed an experimental

mental health program that is addressing homeless mentally ill persons, and the positive results. The

goal of the Disabled American Veterans is to give veterans a hand-up and to return them to

productive lives.

Chairman Thomson feels the homeless issue needs to be addressed, that some County

property may be used for a resource center, and noted his support for a resource center to help return

people to productive lives.

Bob Hertan, President of the Board of Directors for the Vacaville Social Services

Corporation, gave a brief overview of the programs available at Opportunity House, and noted that

there are approximately 160 to 200 people turned away each month. Mr. Hertan noted that in the

future data will be collected on people needing services, services provided by the Veterans

Administration, issues faced by veterans, the dual diagnosis issue, transportation issues, child care

issues, the need for collaborative efforts to eliminate homelessness, and his support to assist the homeless.

(Item 21B) COUNTY TO RETAIN OWNERSHIP OF PROPERTY LOCATED AT THE

SOUTHEAST CORNER OF GOOSE HAVEN ROAD AND CREED ROAD (APN 042-110-150 AND 042-110-200), RECEIVED

Property Manager Michael Lango reviewed the information contained in the Agenda

Submittal from his department dated January 23, 2001, incorporated herein by reference, noting in

income from natural gas exploration and extraction and from grazing rights.

The anticipated revenue

from the property for 2001 is \$400,000 from the natural gas, and the current fair market value is in

the \$200,000 range. At this time there is no defined purpose for the property, but there is potential

for the site to support public services, and recommended retaining ownership of the property.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

retain ownership of the property. So ordered by a vote of 3-0; Supervisors Carroll and Kromm excused.

(Item 22) SOLANO COUNTY LOCAL MENTAL HEALTH BOARD 2000 ANNUAL REPORT, RECEIVED

The Board was provided with an Agenda Submittal from the Department of Health and

Social Services dated January 23, 2001, incorporated herein by reference, regarding the year

2000 Annual Report of the Solano County Local Mental Health Board.

Margaret Rangel, outgoing Chairperson of the Local Mental Health Board, thanked the Board

for their support, noted the encouraging outlook for the Local Mental Health Board, and vacancies

on the board. One of the priorities for the board is to get babysitting services for board members during meetings.

Responding to comments by Supervisor Kondylis relative to women being under served

relative to mental health issues, Ms. Rangel noted the issue would be brought to the board.

Chairman Thomson commended Ms. Rangel for the work and success she has had with the board.

Supervisor Kondylis noted support for on-site babysitting for the commissioners during their meetings.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

accept the Local Mental Health Advisory Board Report for the year 2000. So ordered by a vote

of 3-0; Supervisors Carroll and Kromm excused.

## (Item 23) LOCAL CHILD CARE PLANNING COUNCIL'S PRIORITIES APPROVED

Kathy Largo, Chairperson Local Childcare Planning Council, reviewed the information

contained in the Agenda Submittal from the Children's Network and the Local Child Care Planning

Council dated January 23, 2001, incorporated herein by reference, regarding priorities for child care funding.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

approve the Local Child Care Planning Council's recommendation for local priorities for

increased state preschool, migrant, and general child care funding. So ordered by a vote of 3-0;

Supervisors Carroll and Kromm excused.

(Item 25A) MARION R. BURTON, JOE MOORE, JOSEPH MARTINEZ REAPPOINTED,
