May 1, 2001

The Solano County Board of Supervisors met in regular session on this day at 8:31 a.m.

The meeting was called to order by Chairman Thomson. Present were Supervisors Carroll,

Kromm, Silva, and Chairman Thomson. Supervisor Kondylis arrived at 8:33 a. m.

CLOSED SESSION: The Board moved into Closed Session at 8:32 a.m. to discuss Potential

Litigation: two (2) cases. The Board moved out of Closed Session at 8:49 a.m.

The Solano County Board of Supervisors reconvened on this day at 8:58 a.m. with the

Pledge of Allegiance and a moment of silence.

PRESENTATIONS

(Item 6A) APPEARANCE BY GRAND JURY FOREMAN JOHN WOODS RE RECRUITMENT OF GRAND JURORS FOR THE 2001/2002 SESSION

Grand Jury Foreman for 2000/2001 John Woods appeared before the Board relative to the

recruitment of jurors for the 2001/2002 panel.

Mr. Woods discussed the functions of the Grand Jury as an overall oversight body of

local government, investigating complaints about public agencies and officials, and investigating

some criminal matters. There was further discussion on the responsibilities of the Board in

nominating jurors, desirable qualifications of nominees, the selection process, and the

responsibilities of Grand Jurors.

Responding to questions posed by Supervisor Carroll regarding ultimate jurisdiction for

some elected officials such as the District Attorney, Mr. Woods noted the Grand Jury does not

investigate the courts or any of the court functions, County Counsel or the District Attorney. The

Grand Jury can go to the Attorney General for a resolution of the matter.

Responding to questions posed by Supervisor Kondylis relative to the time required for a

juror, Mr. Woods noted it depends on the activity of the committee the juror is participating on.

The time requirement can be from one day to three days a week. The average is about two days a

week for three to five hours a day. The largest issue is the time commitment.

There was a brief discussion relative to a recent letter from the Grand Jury relative to a

County publication "Solano County 2000 - Report to the Citizens."

(Item 6B) PROCLAMATION COMMENDING ROGER E. LIPMAN FOR HIS SIX YEARS OF DEDICATED SERVICE AS CHAIRPERSON OF THE BOARD OF DIRECTORS OF THE WORKFORCE INVESTMENT BOARD OF SOLANO COUNTY, APPROVED

On motion of Supervisor Silva and seconded by Supervisor Kondylis, the Board acted to

approve a proclamation honoring Roger E. Lipman. So ordered by a vote of 5-0.

On behalf of the Board, Supervisor Silva presented the Proclamation to Mr. Lipman

recognizing him for his work and dedication.

CLOSED SESSION REPORT: CLAIM TO BE FILED AGAINST MR. AND MRS. CHARLES CAMPER RE ABATMENT OF A PUBLIC NUISANCE

County Counsel Dennis Bunting noted by unanimous vote the Board authorized the filing of a complaint to abate a public nuisance against Mr. and Mrs. Charles Camper, pertaining to 417 Ridge Avenue, in the Homeacres area.

APPEARANCE BY CHARLES BAILACHE, VALLEJO, RE CODE ENFORCEMENT

Charles Bailhache, Vallejo, read a prepared statement, incorporated herein by reference,

expressing concern regarding the lack of or selective code enforcement of the Solano County

Regulations and Codes especially in the Benicia Road area that has a large number of out of

compliance and non permitted businesses.

Donald Tipton, Homeacres Improvement Association expressed concern regarding the

date of the formation of the Homeacres Improvement Association being listed as 1940, and noted

the date of formation was in 1920.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

approve the minutes of the Board of Supervisors Meetings of April 3, 2001, April 10, 2001 with the noted modification, and for the Rural North Vacaville Water District for April 3, 2001. So ordered by a vote of 5-0.

(Item 13A) LICENSE FOR INSTALLATION OF RADIO COMMUNICATIONS FACILITIES AND MEMORANDUM OF AGREEMENT WITH NEXTEL COMMUNICATIONS RE INSTALLATION OF RADIO COMMUNICATIONS EQUIPMENT, APPROVED

The Board was provided with an Agenda Submittal from General Services dated May 1,

2001, incorporated herein by reference, the installation of radio communications equipment at

the Vallejo Veteran's Building.

Donald Tipton, Vallejo, noted under alternatives "The revenue can be used to provide

maintenance and improvement funding for the Vallejo Veteran's Building", and suggested

changing the verbiage to read "shall be used to provide maintenance and improvement funding."

This would help maintain the building.

Responding to questions posed by Supervisor Kondylis relative to the installation

placement of the antenna, if the Veteran's organizations have been contacted, approval process

with the City of Vallejo, Michael Lango, General Services, noted Attachment 1 does show

installation of the antenna on the side of the building, and Attachment 2 shows a false penthouse

that would house the antenna. There have been preliminary discussions with the City of Vallejo

resulting in option as listed in Attachment 2. The Veteran's organizations have been contacted.

This item will have to go through the Architectural Heritage Commission and then the City of

Vallejo Planning Commission, and then permitted at the city level, and then final approval by

County departments.

Supervisor Kondylis expressed concern with problems with the roof of the building, and

suggested that the money generated "SHALL" be used for the building, and to go with alternative

1.

Responding to recommendations by Supervisor Kondylis that the funds generated

"SHALL" be used for the building, County Counsel Dennis Bunting noted a report that would be

provided to the Board relative to the condition of the building, and suggested leaving the

language as permissive in the use of the revenue.

County Administrator Michael Johnson noted the funds generated would be shown as

revenue in General Services and would partially be used to off set costs.

Supervisor Kondylis expressed concern regarding the lack of maintenance in the past, and

feels any funds generated should be used for the building.

Responding to questions posed by Supervisor Carroll relative to the installation of the

antenna on top of the building minus the false penthouse, Director of General Services Jim

Werdell reviewed the two alternatives, and described the cellular type of antennas.

Responding to questions posed by Supervisor Carroll regarding Nextel's preference for

installation, Mr. Lango noted that Nextel would prefer to install the antenna on the side of the

building, as shown in attachment 1.

Responding to questions posed by Supervisor Kondylis regarding the condition of the

roof to support the false penthouse, Mr. Lango noted Nextel has done the engineering to ensure

that the roof will support the structure.

Mr. Werdell suggested using the funds for maintenance of the building, except for the

costs that are incurred by the department.

Supervisor Kromm expressed concern with the condition and the longterm plans for the

building.

There was a motion by Supervisor Kondylis and seconded by Supervisor Carroll, to

approve the item based on the information that the Board received, that the funds generated

"SHALL" be used for the building, and to go with alternative number 1. Motion failed by a vote

of 2-3; Supervisors Kromm, Silva, and Chairman Thomson voted no.

On motion of Supervisor Kondylis and seconded by Supervisor Carroll, the Board acted

to approve the departmental recommendations. So ordered by a vote of 5-0.

(Item 13B) DESIGN-BUILD AGREEMENT WITH TONNESEN ENERGY SOURCE,

INC. RE JUVENILE HALL HVAC ENERGY UPGRADES, APPROVED

The Board was provided with an Agenda Submittal from General Services dated May 1,

2001, incorporated herein by reference, regarding awarding an agreement for the design and

construction of the Juvenile Hall HVAC Energy Upgrades.

Responding to questions posed by Chairman Thomson regarding inquires from the

Solano-Napa Building Trades if this is a design build under the current law, Director of General

Services Jim Werdell noted on this project the energy based government code was being

followed, and noted the five proposals that were sent out for the project, and the only response

being from Tonnesen Energy Source, Incorporated.

There was a brief discussion relative to the long-term projects for Juvenile Hall.

On motion of Chairman Thomson and seconded by Supervisor Kondylis, the Board acted

to award the Design Build Agreement to Tonnesen Energy Source, Inc. for the Juvenile Hall

HVAC Energy Upgrades, to authorize the County Administrator to sign the Agreement, and to

authorize the General Services Director to sign contract modifications that fall within the

established project budget. So ordered by a vote of 5-0.

There was a brief discussion relative to compaction issues, which will be addressed at a

future meeting.

On motion of Supervisor Silva and seconded by Supervisor Kromm, the Board acted to

adopt Resolution 2001-99 Amending the List of Numbers and Classifications of Positions

(Assessor/Recorder, Health and Social Services Department, Sheriff's Office). So ordered by a

vote of 5-0.

On motion of Supervisor Kondylis and seconded by Supervisor Silva, the Board acted to

San Francisco Bay Area. So ordered by a vote of 5-0.

INFORMATION RE: AB 1316 (DICKERSON) HORSE

RACING/SATELLITE WAGERING; AND SB 423 (TORLAKSON) ERAF RELIEF FOR LAND USE TRANSACTIONS, RECEIVED

Paul Yoder, Legislative Analyst, Gerber Shaw & Yoder, reviewed the information

contained in the Agenda Submittal dated May 1, 2001, incorporated herein by reference,

regarding a status report on legislation of importance to Solano. Mr. Yoder noted the time and

focus being dedicated to the energy crisis, cuts in the State budget to pay energy costs, 85% to

90% of the bills with funding needs will become 2 year bills, and State revenues are still good.

Responding to comments from Supervisor Silva regarding AB 49 (Washington) relating

to Library Grant funding for after hours youth programs and the many benefits this bill would

have for this area, Mr. Yoder noted he would bring more information back, and recommended

support.

There was consensus of the Board to agree with the recommendations as noted in the

Agenda Submittal, for the bills with the exception of the bills that were removed for further

discussion.

BOARD EXPRESSED SUPPORT FOR AB 1075 (SHELLEY) NURSING RATIOS

Mr. Yoder discussed AB 1075 (Shelley) Nursing Ratios. This bill would increase the

nurse to per patient ration in skilled nursing facilities.

Kimberly Ballard, SEIU Local 250 - Certified Nursing Assistant, noted the current

number of nurses per patient in the facility where she works, patients suffering, feels these

patients are not receiving adequate care, and urged support for this bill.

Nancy Barrett, SEIU Local 250 – Licensed Vocational Nurse (LVN), noted levels of care

in nursing homes is stagnated, nurses are unable to meet the needs of the residents, noted

manipulation of numbers to meet State requirements for care, the need to change conditions in

nursing homes, and urged support for this bill.

Responding to questions posed by Chairman Thomson regarding the number of Registered Nurses (RN) that are on each shift, Ms. Barrett noted any RN's working in the

building are used to meet the ratio even if they do not work with the patients,

usually 2 RN's for

a ration of about 36 to 1.

Responding to questions posed by Supervisor Kromm regarding funding for the added

nurses, Ms. Barrett noted the bill is moving to the appropriations committee. Mr. Yoder noted

current appropriation actions for \$100 million to address nursing issues, and the estimated price

tag fully implemented would be \$300 to \$400 million, with most of the cost for this care coming

through Medi-Cal.

Supervisor Carroll discussed the overall picture of hospital care, Ms. Barrett noted

opposition by the hospital industry to increase staffing levels.

On motion of Supervisor Kondylis and seconded by Chairman Thomson, the Board acted

to support AB 1075 (Shelley). So ordered by a vote of 5-0.

BOARD EXPRESSED OPPOSITION TO AB 1207 (LONGVILLE): WIND TURBINES; AND TO SUPPORT SB 425 (TORLAKSON): DOMESTIC VIOLENCE IF AMENDED

Supervisor Kondylis requested Mr. Yoder investigate the possibility of adding Solano

County to SB 425 (Torlakson); Domestic Violence.

Responding to questions posed by Supervisor Kromm relating to why Contra Costa

County is the only county on this bill, Mr. Yoder feels it will encounter less opposition than a

State-wide bill, and could be viewed as a district bill. Supervisor Kromm feels many other

counties will want to be added.

Responding to questions posed by Supervisor Kondylis regarding AB 685 (Wayne)

Family Day Care Homes – Unannounced Visits on the status, Mr. Yoder discussed the progress

and status of the bill. The rational for this bill is to increase the number of unannounced visits to

help ensure proper care for children.

Mr. Yoder noted AB 1316 (Dickerson) Horse Racing/Satellite Wagering would authorize

the Shasta District Fair to operate an additional satellite wagering facility off the fairgrounds but

within the boundaries of the fair, and noted removal of Solano County from this bill. Solano

County could be added back into the bill. There were many questions surrounding this issue

relative to Solano County; Mr. Yoder will bring additional information back for

consideration,

and no action will be taken at this time.

Responding to comments by Supervisor Kondylis regarding AB 1207 (Longville) Wind

Turbines and the elimination of local control to site windmills, with visual siting problems with

windmills, and with opposing the bill due to the local control issue. Mr. Yoder noted the wind

capabilities in Solano County.

Supervisor Kromm noted prime wind areas located near the Suisun Marsh, the issue of

birds and windmills, the local control issue, and opposition to this bill.

On motion of Supervisor Kondylis and seconded by Supervisor Kromm, the Board acted

to oppose AB 1207, and to support SB 425 if amended to add Solano County. So ordered by a

vote of 5-0.

BOARD EXPRESSED OPPOSITON TO SB 910 (DUNN) HOUSING ELEMENTS

Mr. Yoder discussed SB 910 (Dunn) Housing Elements which would create sanctions for

local government that fail to comply with the State housing element law. There are two punitive

provisions that were outlined. With bill SB 423 (Torlakson) ERAF Relief for Land Use

Transactions would return property taxes to local government that implement certain policies

designed make more livable communities, and provide housing for all segments of the

population.

Responding to questions posed by Chairman Thomson relative to how these bills relate to

the Solano County Orderly Growth Initiative, Director of Environmental Management Birgetta

Corsello noted this legislation could jeopardize the Orderly Growth Initiative if sufficient places

are not found to site housing or to negotiate with the cities for more sites. Harry Englebright,

Department of Environmental Management, presented a brief overview of the problems with the

State requirements for housing, and the requirements developed by ABAG.

Supervisor Kromm feels Solano County is being penalized for land use policies that have

been done through the County Orderly Growth Initiative, and noted strong opposition to SB 910.

Supervisor Silva noted the City of Benicia has been forced to take some

city property to

build affordable housing, effects of this action on local organizations, and the need to challenge

the housing requirements.

Supervisor Carroll discussed local control, ways to accommodate business and population

growth, and the changing attitudes towards agriculture with our society.

On motion of Supervisor Kromm and seconded by supervisor Kondylis, the Board acted

to oppose SB 910. So ordered by a vote of 4-0; Supervisor Carroll excused.

(Item 21) ORDINANCE RELATING TO A CRIMINAL JUSTICE ADMINISTRATIVE (BOOKING) FEE ADOPTED ON FIRST READING; SECOND READING SET FOR MAY 22, 2001

Scheduled on the agenda for this day was consideration of a proposed ordinance which

would remove unnecessary provisions of the code, apportion the fee imposed, simplify the

adoption process, clarify administrative Procedures and make technical corrections to comply

with statutory requirements for the criminal justice administration fee (booking fee).

On motion of Supervisor Kondylis and seconded by Supervisor Kromm, the Board

directed that the proposed ordinance be read by title only. So ordered by a vote of 5-0.

On motion of Supervisor Kondylis and seconded by Supervisor Kromm, the Board acted

to adopted the proposed Ordinance. So ordered by a vote of 5-0.

(Item 22) RESOLUTION NO. 2001-108 ADOPTING FINDINGS ON DECREASE IN

CRIMINAL JUSTICE ADMINISTRATION FEE FOR THE SOLANO COUNTY SHERIFF'S DEPARTMENT, ADOPTED

The Board was provided with an Agenda Submittal from the Auditor-Controller dated

May 1, 2001, incorporated herein by reference, regarding amending the criminal justice

administration fee (booking fee).

Chairman Thomson opened the public hearing. As there was no one who wished to speak

on this matter, the public hearing was closed.

Responding to questions posed by Supervisor Kromm regarding feedback from cities,

Mike Medvedoff, Sheriff's Office, noted there has been no feedback received in

the Sheriff's

Office. John Taylor, County Administrator's Office, noted he has received no feedback.

On motion of Supervisor Kromm and seconded by Supervisor Kondylis, the Board acted

to adopt Resolution No. 2001-108 Adopting Findings on Decrease in Criminal Justice

Administration Fee for the Solano County Sheriff's Department. So ordered by a vote of 5-0.

(Item 23 A) PAT NICODEMUS AND HEIDI ANNA GARCIA APPOINTED TO THE
