- **...** There was a lack of age appropriate activities.
- ❖ The needs and interests of youth differ from adult consumers.
- ❖ The physical facility at the Fairfield location was poorly maintained, dirty, and depressing.

# **Project: Youth Oriented Wellness and Recovery Center**

This project would provided a wellness and Recovery Center targeted specifically for youth.

The center should be centrally located. The group felt Fairfield or Solano Community College would be good locations. This is where the people are. The location should be close to transportation and have the ability to provide transportation.

The physical facilities would:

- ❖ Be cleaner/no graffiti
- ❖ Be provide an uplifting atmosphere
- ❖ Contain computers (10-20)
- ❖ Include a sound room for recording music
- ❖ Space for treatment and groups (including both consumer and family groups)
- ❖ Include a kitchen suitable for cooking classes.
- ❖ Safe environment
  - No weapons policy (Metal detectors were suggested by some by others did not seem to buy in)
  - o Action by staff to deal with disruptive individuals

The program and staff at the center should provide:

- Independent Living Skills classes

  - Medication education
  - o Banking/financial management
  - o Anger Management

- ❖ Large screen TV
- Peer counselors
- ❖ Job counseling/placement
  - o Job Developer
  - o Career classes
- ❖ Access to information/directories of service
- ❖ Ability to address dual diagnosis consumers
  - o 12 step model geared to youth
  - o No Fail policy
