<p>Briefly describe your plan for using the Training, Technical Assistance and Capacity Building funding and indicate (if known) potential partner(s) or contractor(s).</p> <p><b>Solano County Health &amp; Social Services Mental Health Division has partnered with First 5 Solano and the early childhood developmental health community to gather extensive community input to develop a countywide Early Childhood Developmental Health Strategic Plan. That plan was used as the foundation for the integrated service design of the MHSA Prevention and Early Intervention Plan, which features an intentional, coordinated and measurable set of child- and family-centered mental/developmental health activities and outcomes to promote the healthy growth of children aged 0-5.</b></p> <p><b>Through an RFP process, five agencies have been awarded funding to implement the plan for 0-5 mental health prevention and early intervention services. In addition, the RFP for school age children who are at risk of school failure or involvement with the juvenile justice system is being issued in February 2009 to begin next Fiscal Year.</b></p> <p><b>We would like training, technical assistance, and capacity building to the providers of prevention and early intervention mental health services for children 0-5 and school aged youth to assist them in providing high quality coordinated and comprehensive services.</b></p>	
<p>The County and its contractor(s) for these services agree to comply with the following criteria:</p> <ol style="list-style-type: none"> <li>1) This funding established pursuant to the Mental Health Services Act (MHSA) shall be utilized for activities consistent with the intent of the Act and proposed guidelines for the Prevention and Early Intervention component of the County's Three-Year Program and Expenditure Plan.</li> <li>2) Funds shall not be used to supplant existing state or county funds utilized to provide mental health services.</li> <li>3) These funds shall only be used to pay for the programs authorized in WIC Section 5892.</li> <li>4) These funds may not be used to pay for any other program.</li> <li>5) These funds may not be loaned to the state General Fund or any other fund of the state, or a county general fund or any other county fund for any purpose other than those authorized by WIC Section 5892.</li> <li>6) These funds shall be used to support a project(s) that demonstrates the capacity to develop and provide statewide training, technical assistance and capacity building services and programs in partnership with local and community partners via subcontracts or other arrangements to assure the appropriate provision of community-based prevention and early intervention activities.</li> <li>7) These funds shall be used to support a project(s) that utilizes training methods that have demonstrated the capacity to increase skills and promote positive outcomes consistent with the MHSA and PEI proposed guidelines.</li> </ol> <p><b>Certification</b></p> <p>I HEREBY CERTIFY to the best of my knowledge and belief this request in all respects is true, correct, and in accordance with the law.</p> <p>_____ Director, County Mental Health Program (original signature)</p>
