I am pleased to announce the award of funding for Request for Proposal (RFP) #G099-0223-09 Mental Health Services Act Prevention and Early Intervention School Age Project.

Based on recommendations from the Review Panel and fiscal review, two applicants have been selected for funding:

- Solano County Office of Education will receive up to \$421,729 annually (adjusted for inflation) to provide educational liaison to multidisciplinary teams, system-wide coordination, and school-based targeted assistance in districts that did not apply for or receive funding.
- Vacaville Unified School District will receive up to \$114,271 annually (adjusted for inflation) to provide school-based targeted assistance in their own district.

Megan Richards, Prevention and Early Intervention Project Manager, will contact the selected Applicants shortly to begin contract negotiations. Services are estimated to being July 1, 2009. Actual funding is contingent on approval of County Counsel and establishment of fully executed contracts with County of Solano. No work can begin prior to contract execution. Contracted funding is contingent upon the continued availability of Mental Health Services Act Prevention and Early Intervention funds.
