<u>Recommendation</u>: Approve award of up to \$421,729 to Solano County Office of Education and \$114,271 to Vacaville Unified School District annually (adjusted for inflation), as recommended by the Review Panel and fiscal review for RFP #G099-0223-09 for the Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) School-Age Project.

Source of funding: Solano County Health & Social Services Mental Health Service Act Prevention and Early Intervention funds.

Note: The actual funding is contingent on approval of County Counsel and establishment of fully executed contracts with County of Solano. No work can begin prior to contract execution. Contracted funding is also contingent upon the continued availability of MHSA PEI funds.

Summary:

Solano County Health & Social Services Mental Health Division completed an extensive community planning process in response to the Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) Community Planning Guidelines. Solano County's MHSA PEI plan was approved by the California Department of Mental Health (DMH) and the Mental Health Services Oversight and Accountability Commission (MHSOAC) on September 9, 2008.

The school age component of the MHSA PEI plan, targeting school age youth at risk for school failure or in early involvement with the juvenile justice system, was consolidated in Request for

Proposal (RFP) # G099-0223-09. A Review Panel and fiscal review process created recommendations for funding based on Proposals received in response to this RFP. Solano County Health & Social Services Mental Health Division is responsible for administration of the School Age Project.

Financing:

Funding for this these awards is provided by MHSA PEI funds that are requested annually from the California Department of Mental Health.

The funding for this project is \$536,000 annually for three years (adjusted each year for inflation) for a total funding amount of \$1,656,722. Contracted funding is contingent upon continued availability of MHSA PEI funds.

Background/Discussion:

The MHSA PEI Community Planning Process identified school age youth as a target population for mental health prevention and early intervention services. Work groups addressing children at risk for school failure and children at risk of experiencing juvenile justice involvement indentified best practice and evidence based prevention and early intervention strategies outlined in the MHSA PEI plan, including: a school based targeted student assistance program to address the needs of students grades 4-8 at risk of school failure due to social/emotional issues; and an educational liaison to juvenile probation multi-disciplinary teams for secondary students who have had their first contact with the juvenile justice system.

Both of these strategies, along with a system-wide coordination function were solicited in RFP #G099-0223-09.

RFP Process, Review Panel Recommendations:

Request for Proposals (RFP) #G099-0223-09 was released on February 23, 2009 with Proposals due on March 23, 2009. A mandatory Applicant Conference was held on March 2, 2009. Questions and answers from the Applicant Conference were distributed to the attendees and posted on the Solano County website on March 5, 2009.

The Applicants, services proposed, and amounts requested are as follows:

All seven proposals were forwarded to a four-member Review Panel, composed of a mental health clinician, a supervising juvenile probation officer, and two experts in school based mental health. The Review Panel individually scored each proposal on its own merits. The Review Panel met on March 31, 2009 and discussed the Proposals. Final scores were assigned and averaged to rank Proposals. Review Panel recommendations were made for Agencies to fund and funding amounts. These are summarized in the following table:

The Review Panel recommended school based targeted assistance be provided in Vacaville and Vallejo by their own school districts, and the Solano County Office of Education provide school based targeted assistance in other districts commensurate with need. The Review Panel also recommended the Solano County Office of Education provide educational liaison to multidisciplinary teams and system-wide coordination county-wide.

To supplement their findings, the Review Panel made comments and suggestions that will be useful to staff in working with Applicants to develop finalized budgets, scopes of work, evaluation plans, and contracts. The Proposals will represent the starting point for contract negotiations and the finished products will be developed by working closely with the Applicants over the contract development period.

Proposals that were recommended for funding by the Review Panel were submitted to H&SS Administration for fiscal capability and expenditure plan review. These are summarized in the following table:

Not recommended for funding based on documentation provided.

The fiscal review was based on a review of the Applicant's audited financial statements for FY 06/07 & FY 07/08, the budget proposal, staffing, and cost justifications. Although an Applicant may have demonstrated a high level of solvency during the audited fiscal years, the fiscal review could not attest to the Applicant's current financial stability. All Applicants rely heavily on property tax revenues as well as federal and state funding. Due to the current economic downturn, there is a high probability that these funding sources are heavily impacted. The impact of the probable significant decline in revenues was not included as a scoring factor.

Taking into account both the recommendations by the Review Panel and the fiscal review, it is recommended that Vacaville Unified School District receive \$114,271 annually adjusted for inflation to provide school based targeted assistance in their district, and Solano County Office

of Education receive \$421,729 annually adjusted for inflation to provide an educational liaison to multidisciplinary teams, system-wide coordination, and school based targeted assistance in districts that did not apply for or receive funding.

Alternatives:

The H&SS Mental Health Director has the option of approving the Review Panel and fiscal review recommendations as offered or overriding/changing any or all of the recommendations. In addition, the Mental Health Director may make recommendations for contract negotiations.

Other Agency Involvement:

Per the guidelines of the MHSA PEI Community Planning, many community agencies and schools were involved in drafting the MHSA PEI School Age Project on which this RFP was based, including law enforcement, probation, school districts, Solano County Office of Education, community agencies, family resource centers, and family members of students referred for student support services.
