1	Is this RFQ for only residential services, day treatment (PHP, IOP, Outpatient), or both?	For residential only – day treatment and supplemental mental health services.
2	Do these services have to be performed in Solano County?	Yes
3	Is this RFQ an intent to award multiple providers or is it a single award?	Multiple providers.
4	In the cost proposal, may we show MHSA funds to cover innovative practices, prevention and early intervention, or full-service partnerships as the 5% County match for EPSDT?	Yes
5	In the cost proposal, may we show SB 90 funding to support non-rehab services for students who are not eligible for EPSDT?	Yes, with the understanding that SB90 funding may not be used to match the EPSDT funding
6	If a technical proposal has the potential to be a statewide innovation project, may we show MHSA funding as part of the cost proposal?	Yes
