 - X waivers are no longer needed for ED docs to prescribe Buprenorphine.
 - Tranq dope- a horrific drug is being seen on the streets of the east coast. It is an animal tranquilizer (Xylazine) mixed with Fentanyl or any other opioid.
 - Carol met with Supervisor Hannigan and she is supportive of Carols application for ADAB.
 - Deanna Allen is holding a training on February 17th, 2023 in Fairfield at the county building.
