Eligibility for Appointment of Counsel and Notice to Defendant

If an attorney is appointed to represent you, the Court will, at the conclusion of the criminal proceedings, after a hearing, make a determination of your ability to pay all or a portion of the cost of the attorney. If the Court determines that you are at that time able to pay, the court will order you to pay all or part of such cost.

Such an order will have the same force and effect as a judgment in a civil action and will be subject to execution. Under § 987(c) P.C. this Financial Statement is confidential and privileged, and not admissible in evidence in any criminal proceeding except in the prosecution of an alleged offense of perjury based upon material contained in this statement. This financial statement shall not be confidential and privileged in a proceeding under § 987.8 P.C.
